Elizabeth Brannen is the Managing Partner of Stris & Maher. She is also a first-chair trial lawyer who represents select clients in high-stakes business disputes.

Under Elizabeth's leadership, Stris & Maher has achieved widespread recognition as one of the nation's preeminent litigation boutiques. During her tenure, for example, *The American Lawyer* has twice named the firm a National Boutique of the Year Finalist (2019, 2022), an annual honor given to just seven firms "at the core of industry-changing matters, leading the charge on their clients' most important cases and operating at a level that sets them apart from their peers."

In addition to serving as the firm's chief executive, Elizabeth maintains an active litigation practice representing clients in significant intellectual property and other complex business disputes.

Natural communicator

Before ever setting foot in a courtroom, Elizabeth was already a proven advocate. In high school, she was the national Lincoln-Douglas debate champion. And in college, she became the second woman ever to win the national championship of the American Parliamentary Debate Association—an organization that has produced some of the country's most influential lawyers

Widely respected for her soft skills both in and out of the courtroom, Elizabeth has the rare ability to convert skeptics and neutralize conflict in almost any contentious professional setting.

Veteran IP litigator

Before joining Stris & Maher in 2015, Elizabeth served as the Director of Intellectual Property at Barnes & Noble, as Corporate Counsel in Oracle's litigation group, and as a patent litigator at a leading global IP firm.

Elizabeth now leads the firm's patent litigation practice. Her work is national in scope, with recent cases ranging from district courts in California and Utah to Virginia and New York. She has achieved significant victories for global technology leaders and personally preserved them on appeal, including before the Federal Circuit where she began her career two decades ago as a clerk to the Honorable Arthur J. Gajarsa.

Elizabeth is also an expert in copyright, Lanham Act, and trade secret litigation. She served as the primary substantive authority for the firm's recent copyright cases before the U.S. Supreme Court (*Fourth Estate v. Wall-Street.com*, 139 S. Ct. 881 (2019) and *Unicolors v. H&M*, 142 S. Ct. 941 (2022)) and its recent Lanham Act trial, defeating a \$180 million false advertising claim and earning [Top 20 Defense Verdict](#) recognition from the *Daily Journal*.
